2. I AM AWARE THAT HUNTING AND SHOOTING IS A HAZARDOUS ACTIVITY. I AM VOLUNTARILY PARTICIPATING IN THIS ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED, AND I HEREBY AGREE TO, AND DO HEREBY ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH, AND AGREE TO ASSERT NO CLAIMS AGAINST THE LANDOWNERS, MCDOWELL HUNTING PRESERVE, DOUBLE M FARMS, INC AND THEIR EMPLOYEES AND VERIFY THIS STATEMENT BY PLACING MY INITIALS HERE: [redacted]

SAFETY RULES AND REGULATIONS

3. The undersigned member hereby agrees to abide by each and all of the foregoing rules and regulations and to assume all responsibility for guests to do the same. The undersigned acknowledges that he/she has read and understands the foregoing rules and regulations, and failure to abide by any of the rules and regulations may be grounds for immediate terminations of his/hers membership without compensation for unclaimed birds.
1. No hunting within 200 yards of back house and pens
 2. Members are responsible for the conduct of their guests
 3. All members and guests must sign in and out, and tag all birds
 4. Hunter orange must be worn by everyone while in the fields
 5. Hunt only in assigned field or open fields (fields not assigned to someone else)
 6. Shoot only the species of bird/s that you buy, extras will be charged to you
 7. Eye & Ear protection must be worn at shooting range
 8. At shooting range, keep all guns unloaded unless in shooting stand
 9. Speed limit is 10 mph
 10. No hunting when visibility is less than ¼ mile
 11. All dogs must be leashed except when in the field
 12. Shooting hours are between 8am and 5pm
 13. No alcohol consumption
 14. Anyone under 18 must be accompanied by parent or guardian
 15. All guns must be unloaded when within 60 yards of buildings and parking areas
 16. Pick up all trash that you may have including shells
 17. All members and guests present (shooters and non-shooters) on the hunting grounds must sign and return a copy of the AGREEMENT AND RELEASE FROM LIABILITY form
 18. Failure to abide by any of the rules and regulations may be grounds for immediate termination of your membership without compensation for unclaimed birds
